SURVEYOR'S CERTIFICATE

I, Keith R. Russell, do hereby represent that I am a Professional Land Surveyor and that I hold Certificate no. 164386 as prescribed by the laws of the State of Utah and I have made a survey of the following described property. The purpose of this survey is to show the boundary of the parcel and the improvements that determine the boundary as well as the improvements within the parcel. Great Basin Engineering had completed a survey of property that surrounds this parcel of the north, west and south, which survey I have honored and used to establish the boundary lines of this parcel. Information from the Great Basin Engineering survey, where applicable has been noted herein. The fence line on the north side of the property, and the rock along the southwesterly side of the property is referenced in the description of the neighboring property by the Great Basin Survey. I have honored these calls and physical monuments.

The Basis of Bearing is from found Weber County Section Corner Survey Monuments at the Southwest and Northwest Corners of Section 12, Township 6 North, Range 2 East, Salt Lake Base and Meridian. The section breakdown into aliquot parts was taken from the Great Basin Engineering survey referenced herein.

Part of the Southwest Quarter of the Southwest Quarter of Section 12, Township 6 North, Range 2 East, Salt Lake Base and Meridian, U.S. Survey. Beginning at a point that is 68.2 feet West and 346 feet South from the Center of the Southwest Quarter of said Section 12, and running:
Thence South 78° West 10 feet;
Thence South 14° West 31.5 feet to a rock wall;
Thence South 49°30' East along said rock wall 152 feet more or less to the northwesterly bank of South Fork River;
Thence in a northerly direction along the said bank of South Fork River to a point that is North 78° East 74 feet from the point of beginning;
Thence South 78° West 74 feet, to the point of beginning.

Together with a right-of-way along the Old Highway, the center line of which said right-of-way described as follows:
Beginning at a point that is 68.2 feet West and 346 feet South from the Center of the Southwest Quarter of said Section 12, and running:
Thence North 14°27' West 230 feet, more or less, to the State Road.

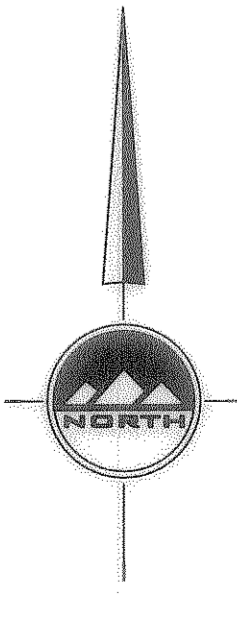
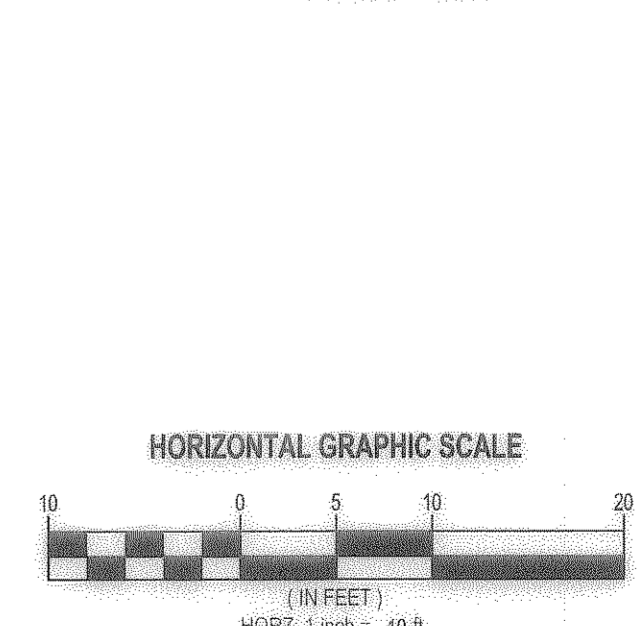

Beginning at the intersection of a fence line extension and the west bank of the South Fork of the Ogden River, said point being South 0°03'31" West 328.62 feet along the sixteenth line (331.71 feet on Great Basin Survey) to the extension of a fence line and South 79°14'59" West 21.05 feet (South 78°40'36" West on Great Basin Survey) from the Center of the Southwest Quarter of said Section 12, and running:
Thence South 79°14'59" West 86.55 feet to and along a fence line to a fence corner;
Thence South 15°18'30" West 33.09 feet along a fence line to the extension of the northeasterly side of a rock wall;
Thence South 35°07'31" East 52.33 feet along the northeasterly side of a rock wall to an angle point in said wall;
Thence South 48°08'23" East 33.15 feet along the northeasterly side of a rock wall to an angle point in said wall;
Thence South 61°48'59" East 17.54 feet along the northeasterly side of a rock wall to an angle point in said wall;
Thence South 77°12'17" East 14.90 feet along the northeasterly side of a rock wall to an angle point in said wall;
Thence South 53°48'55" East 48.73 feet along the northeasterly side of a rock wall, through an existing shed and beyond the end of the rock wall to the sixteenth line;
Thence North 0°03'31" East 20.32 feet along the sixteenth line to the west top bank of the South Fork of the Ogden River;
Thence North 18°34'20" West 18.93 feet along the west top bank to an angle point in said bank of the South Fork of the Ogden River;

Thence North 18°11'30" West 28.89 feet along the west top bank of the South Fork of the Ogden River to the point of beginning.

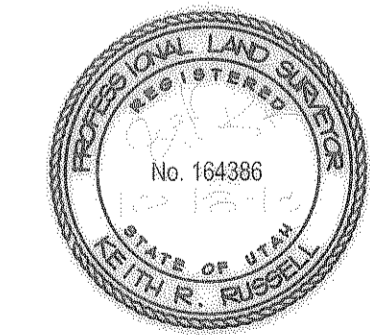
