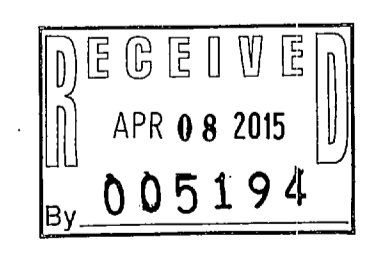
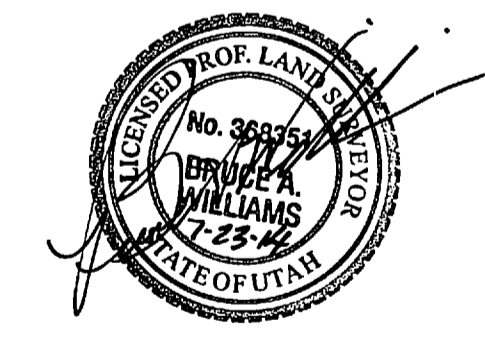
- NARRATIVE:**
- THIS SURVEY WAS MADE AT THE REQUEST OF SOULASITH KIPHIBANE FOR THE PURPOSE OF PROVIDING A BOUNDARY SURVEY MAP FOR A PARCEL OF LAND LOCATED AT 2015 MONROE BLVD, OGDEN CITY, WEBER COUNTY, UTAH, SAID PROPERTY BEING COUNTY PARCEL 01-065-0046 AS SHOWN AND DESCRIBED HEREON.
 - DOCUMENTS FOUND AND USED IN THE COURSE OF THIS SURVEY WERE AS FOLLOWS: OFFICIAL PLAT OF BLOCK 15, PLAT B, OGDEN CITY SURVEY AS RECORDED IN THE WEBER COUNTY RECORDER'S OFFICE, AND DEEDS OF THE SUBJECT PROPERTY AND SURROUNDING PROPERTIES.
 - THE BASIS OF BEARING FOR LINES SHOWN ON THIS SURVEY IS SOUTH 01°18'31" WEST BETWEEN THE STREET MONUMENT AT THE INTERSECTION OF MONROE BLVD. & 20TH STREET, AND THE STREET MONUMENT AT THE INTERSECTION OF MONROE BLVD. & 21ST STREET.
 - NO BENCH MARK WAS ESTABLISHED FOR THIS SURVEY.
