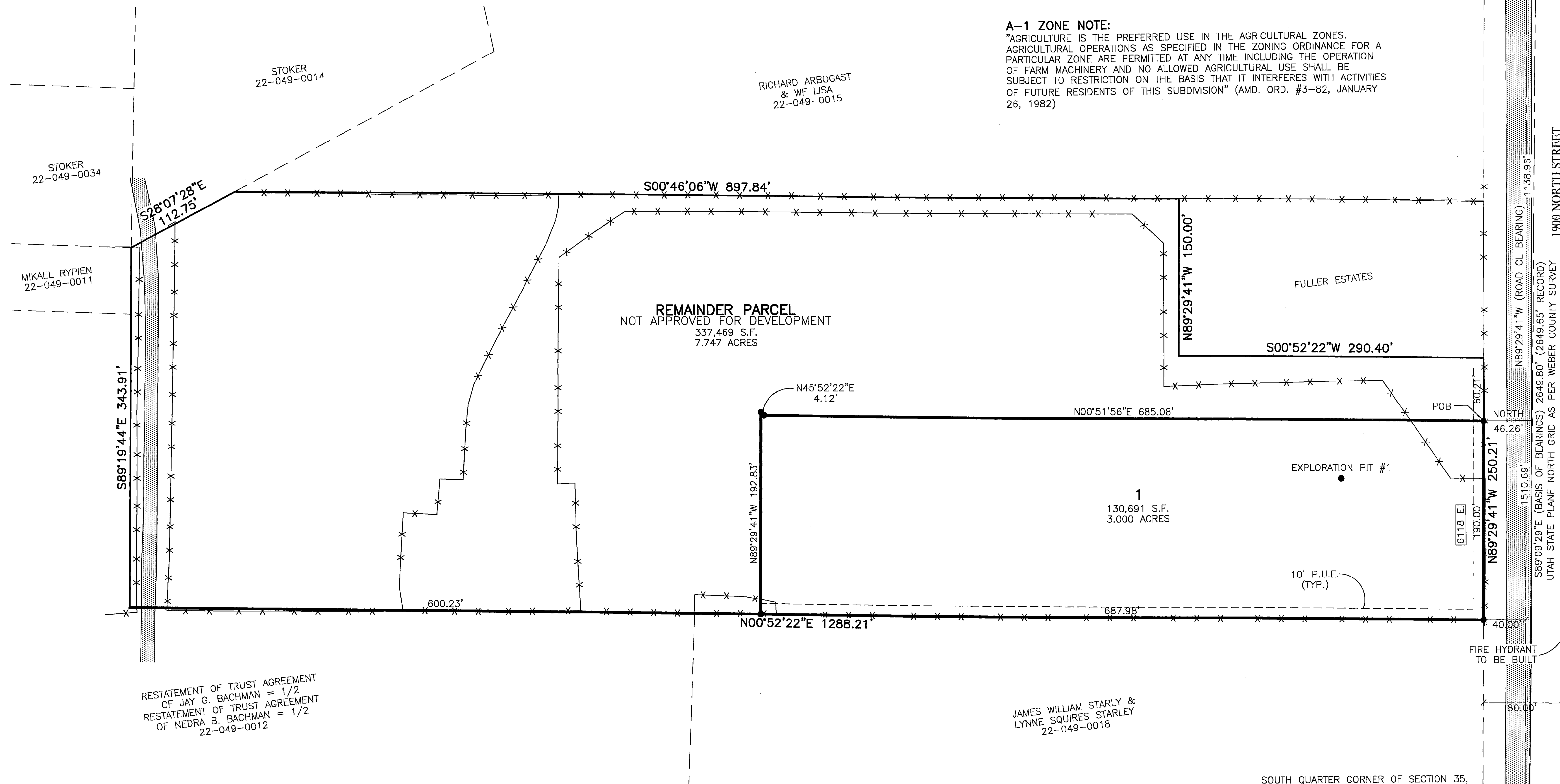

BOUNDARY DESCRIPTION

PART OF THE SOUTHEAST QUARTER OF SECTION 35, TOWNSHIP 7 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT ON THE NORTH RIGHT OF WAY LINE OF 1900 NORTH STREET, SAID POINT BEING S89°09'29"E 1510.69 FEET AND NORTH 46.26 FEET FROM THE SOUTH QUARTER CORNER OF SAID SECTION 35; THENCE N00°51'56"E 685.08 FEET; THENCE N45°52'22"E 4.12 FEET; THENCE N89°29'41"W 192.83 FEET; THENCE S00°52'22"W 687.98 FEET TO THE NORTHERLY RIGHT OF WAY LINE OF 1900 WEST STREET; THENCE S89°29'41"E 190.00 FEET ALONG SAID RIGHT OF WAY LINE TO THE POINT OF BEGINNING.
CONTAINING 130,691 SQUARE FEET OR 3.000 ACRES

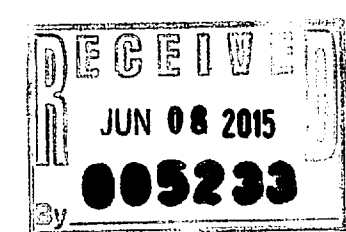
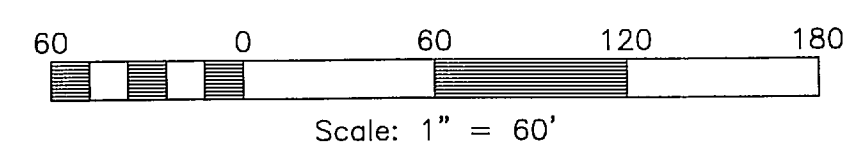
THE PURPOSE OF THIS PLAT IS TO CREATE A ONE LOT SUBDIVISION WITH A REMAINDER PARCEL AS SHOWN. THE BOUNDARIES WERE DETERMINED BY USING EXISTING DEEDS, OCCUPATIONAL EVIDENCE, AND SURVEYS IN THE AREA. NO ROAD IS BEING DEDICATED WITH THIS PLAT. THE ROAD AS SHOWN WAS DETERMINED BY DEED, WHICH MATCHED OCCUPATION AND SURROUNDING DEEDS AND SURVEYS. ALL BOUNDARY CORNERS WERE SET WITH A 5/8" X 24" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".
