


THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN THE CENTER QUARTER AND THE EAST QUARTER CORNER OF SECTION 5, TOWNSHIP 6 NORTH, RANGE 2 WEST, SHOWN HEREON AS S89°14'16"E.

#### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO CHANGE THE CONFIGURATION OF THE EXISTING SUBJECT PARCELS, AS SHOWN ON THIS PLAT. THERE ARE NO NEW PARCELS BEING CREATED WITH THIS TRANSACTION. THE BOUNDARY WAS DETERMINED USING DEED CALLS, WHICH FIT WITH ADJACENT DEEDS AND THE REDWOOD LANE SUBDIVISION.


