

PROPERTY DESCRIPTION

All of Lot 5, Westview Subdivision Phase 1 and all of that property hereon described as Parcel B being a part of the Southeast Quarter of Section 24, Township 7 North, Range 2 West, Salt Lake Base & Meridian, U.S. Survey, Pleasant View City, Weber County, Utah, being more particularly described as follows:

Beginning at a point on the Northwesterly line of Lot 89, Westview Subdivision Phase 1, as recorded with the office of the Weber County Recorder, being 488.07 feet North 0°48'35" East along the Section line, 1152.17 feet North 52°13'25" West along the Southwesterly Line of Pleasant View Drive and 240.77 feet South 56°59'31" West from the Southeast Corner of said Section 24; and running thence South 56°59'31" West 78.97 feet along said Northwesterly line of Lot 89; thence South 31°10'58" East 60.63 feet along the Southwesterly line of said Lot 89 to the most Northerly corner of Lot 6, said Westview Subdivision Phase 1; thence South 58°06'34" West 142.08 feet along the Northwesterly line to the most Westerly corner of said Lot 6 and Northeasterly line of 3300 North Street; thence along the Southwesterly line of said lot 6 and said Northeasterly line of 3300 North Street the following two (2) courses: North 32°10'43" West 45.00 feet to a point of curvature; and 56.30 feet Northwesterly along the arc of a 280.00 foot Radius curve to the left through a Central Angle of 11°31'12" (Long Chord bears North 37°56'19" West 56.20 feet) to the most Southerly corner of Lot 4, said Westview Subdivision Phase 1; thence North 46°18'05" East 124.59 feet along the Southeasterly line of said Lot 4; thence North 32°45'24" West 70.64 feet along the Northeasterly line of said Lot 4 to the most Southerly corner of said Lot 3, said Westview Subdivision Phase 1; thence North 56°59'31" East 105.00 feet along the Southeasterly line of said Lot 3; thence South 32°45'24" East 136.92 feet to the point of beginning.

This Property Survey was requested by Mr. Jeremy Felt for the purpose of re-establishing the boundaries and Topography of the hereon described Lot.


Nails were found in the curb at the front lot corners of Lot 5, and a Rebar and Cap was found at the Southwest Corner of Lot 89, as shown hereon, and were honored.


Brass Cap Street Monuments were found at the intersection of 3300 North Street and 1325 West Street and the intersection of 3300 North Street and 1260 West Street. A line bearing South 39°17'16" North Street these two monuments was used as the Basis of Bearings for this survey.


Lot corners not found were set with a 5/8" rebar with Plastic Cap, or Nail and Brass Washer, marked "Great Basin Engineering Inc, as indicated hereon.
