BEGINNING AT A POINT ON THE EASTERLY RIGHT-OF-WAY LINE OF EASTWOOD BLVD BEING LOCATED SOUTH 00°00'00" EAST 620.70 FEET AND NORTH 90°00'00" EAST 101.53 FEET FROM THE CENTER OF SAID SECTION 23 (BASIS OF BEARING NORTH 88°58'33" EAST FROM CENTER OF SECTION 23 TO WEST QUARTER CORNER SECTION 23); RUNNING THENCE NORTH 44°31'34" EAST 169.06 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF COMBE ROAD; THENCE ALONG SAID WESTERLY RIGHT-OF-WAY LINE SOUTH 38°45'00" EAST 100.00 FEET; THENCE SOUTH 39°05'33" WEST 139.71 FEET TO THE EASTERLY RIGHT-OF-WAY LINE OF SAID EASTWOOD BLVD.; THENCE ALONG SAID EASTERLY RIGHT-OF-WAY LINE NORTH 54°41'33" WEST 114.01 FEET TO THE POINT OF BEGINNING.
