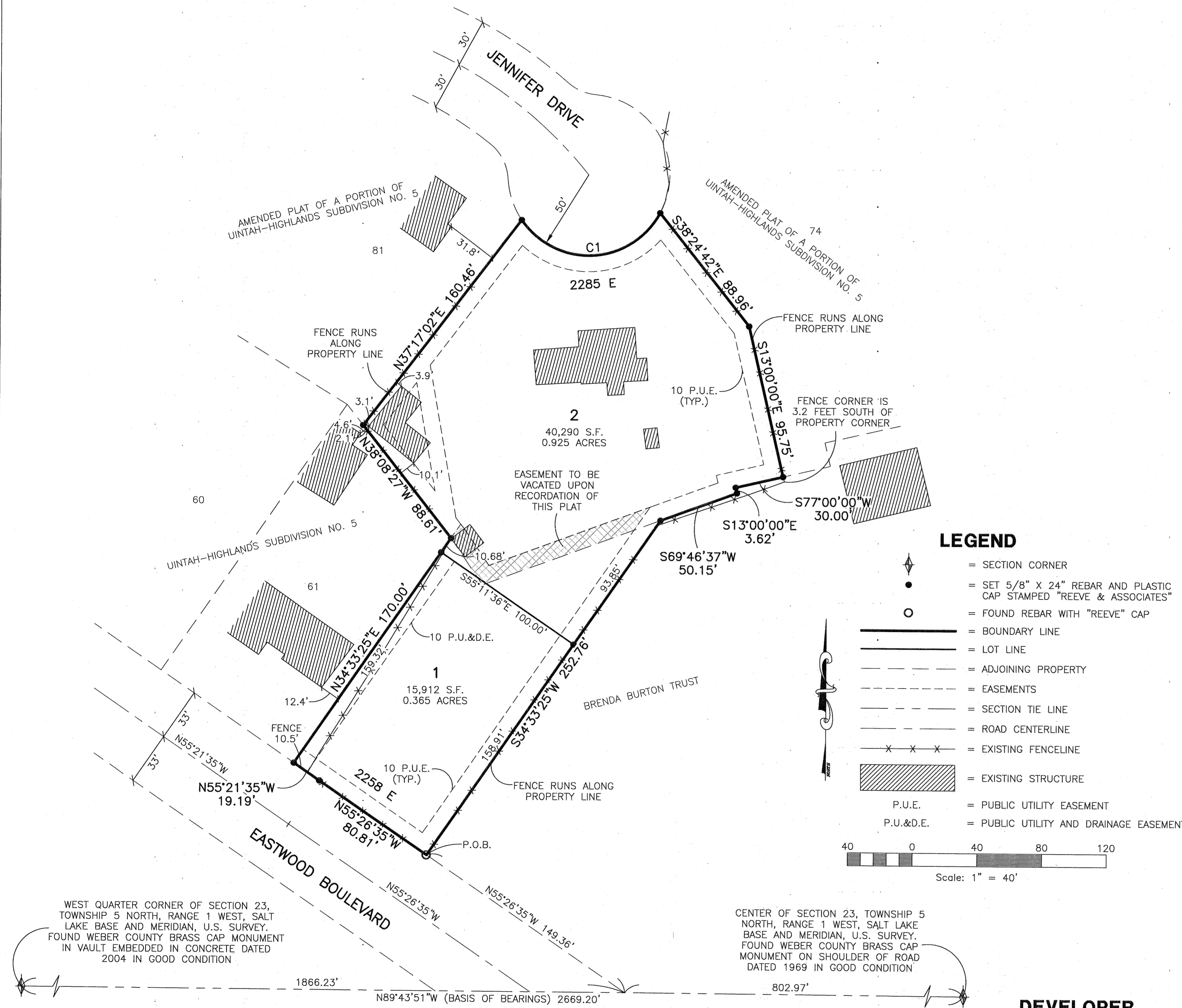


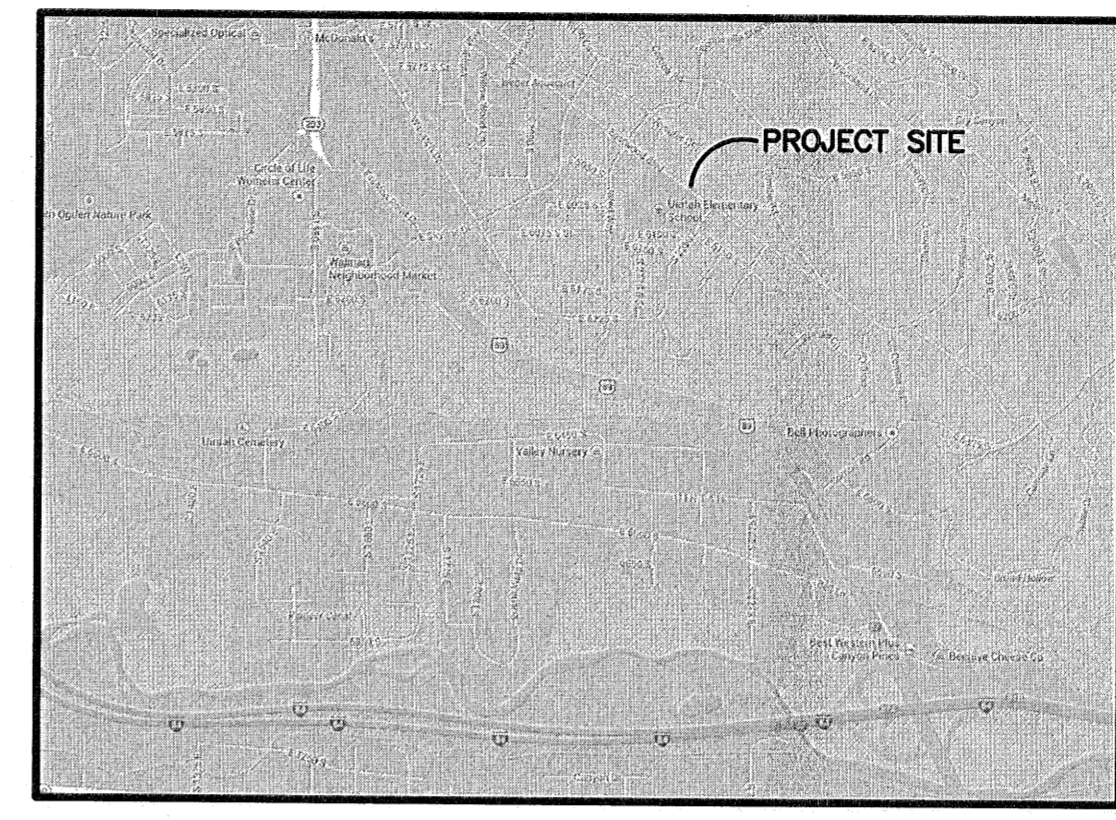
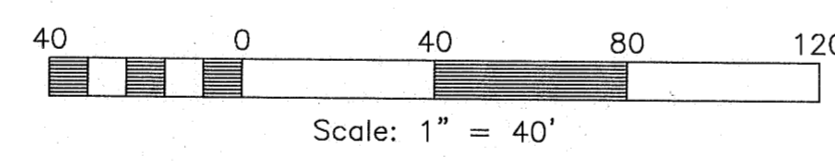
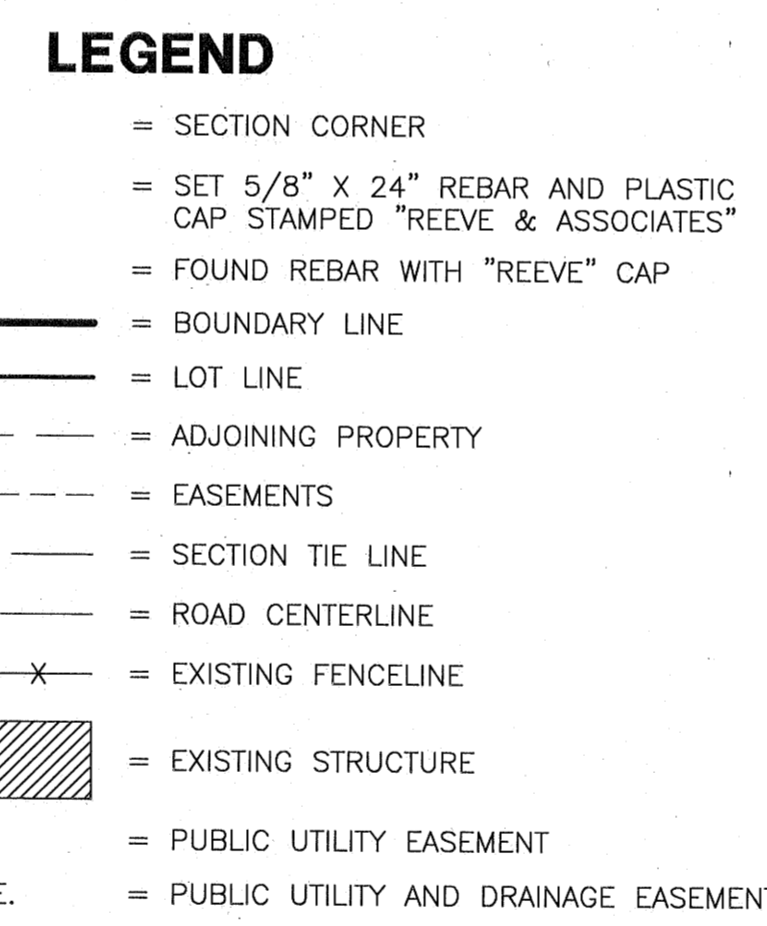

BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN THE CENTER AND THE WEST QUARTER CORNER OF SECTION 23, TOWNSHIP 5 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY. SHOWN HEREON AS N89°43'51"W.

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO CREATE AN AMENDED PLAT OF LOT 79 OF THE AMENDED PLAT OF A PORTION OF UINTAH-HIGHLANDS SUBDIVISION NO. 5 AS RECORDED IN THE WEBER COUNTY RECORDER'S OFFICE. ONE REBAR MARKED "REEVE" WAS FOUND AND ACCEPTED AT THE POINT OF BEGINNING AS SHOWN ON THE PLAT. TWO WEBER COUNTY BRASS CAP MONUMENTS WERE FOUND AND ACCEPTED AT THE WEST QUARTER CORNER AND THE CENTER OF SECTION 23. ALL BOUNDARY AND LOT CORNERS NOT FOUND WERE SET WITH A 5/8" X 24" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".

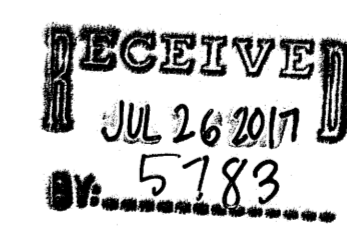
BOUNDARY DESCRIPTION

PART OF THE NORTHWEST QUARTER OF SECTION 23, TOWNSHIP 5 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF EASTWOOD BOULEVARD; SAID POINT BEING N89°43'51"W 802.97 FEET AND N55°26'35"W 149.36 FEET FROM THE CENTER OF SAID SECTION 23; THENCE ALONG SAID NORTHERLY RIGHT OF WAY LINE THE FOLLOWING TWO (2) COURSES: (1) N55°26'35"W 80.81 FEET; AND (2) N55°21'35"W 19.19 FEET; THENCE N34°33'25"E 170.00 FEET; THENCE N38°08'27"W 88.61 FEET; THENCE N37°17'02"E 160.46 FEET; THENCE ALONG A CURVE TURNING TO THE LEFT WITH AN ARC LENGTH OF 102.75 FEET, A RADIUS OF 50.00 FEET, A CHORD BEARING OF N86°52'40"E, AND A CHORD LENGTH OF 85.60 FEET; THENCE S38°24'42"E 88.96 FEET; THENCE S13°00'00"E 95.75 FEET; THENCE S77°00'00"W 30.00 FEET; THENCE S13°00'00"E 3.62 FEET; THENCE S69°46'37"W 50.15 FEET; THENCE S34°33'25"W 252.75 FEET TO THE POINT OF BEGINNING.
