


BOUNDARY DESCRIPTION

NARRATIVE

THE PURPOSE OF THE SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JASON CORNIA. THE CONTROL USED WAS THE EXISTING OGDEN CITY SURVEY MONUMENTATION SURROUNDING BLOCK 9, MOUNTAIN VIEW ADDITION AS SHOWN HEREON. THE BOUNDARY WAS DETERMINED BY THE DEDICATED PLAT OF SAID MOUNTAIN VIEW ADDITION RECORDED AT BOOK 05, PAGE 017 OF THE WEBER COUNTY RECORDS. OWNERSHIP WAS DETERMINED BY WARRANTY DEED RECORDED AS ENTRY NUMBER 2864334 OF THE WEBER COUNTY RECORDS. THE BASIS OF BEARING IS THE MONUMENTED CENTERLINE OF POLK AVENUE BETWEEN 21ST STREET AND 22ND STREET WHICH BEARS SOUTH 01°17'22" WEST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING.
