

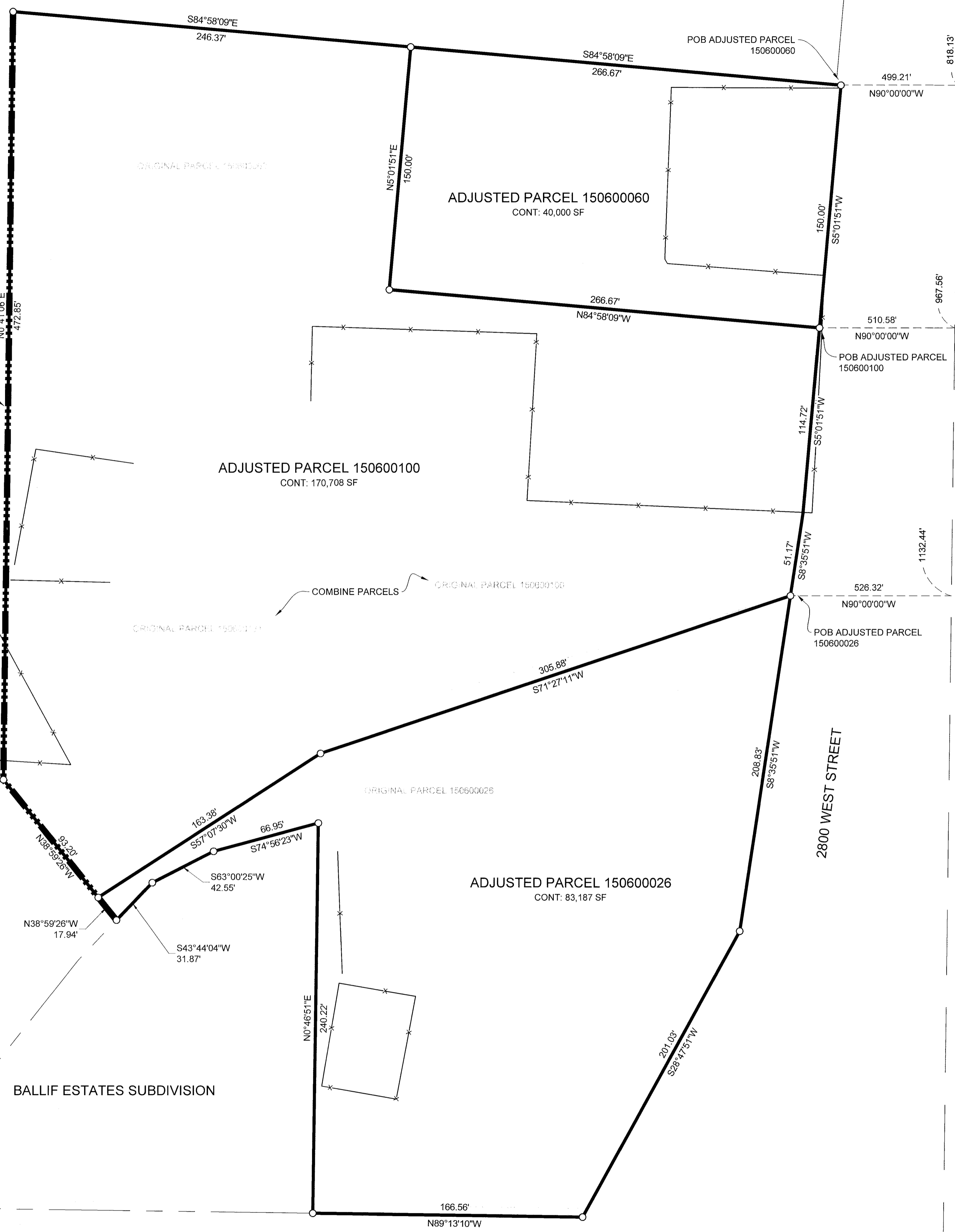

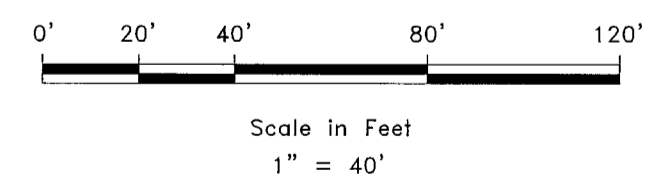

NARRATIVE

THE PURPOSE OF THE SURVEY WAS TO ADJUST PARCELS 150600060, 150600026 AND COMBINE PARCELS 150600131 AND 150600100, AS SHOWN AND NOTED HEREON. THE SURVEY WAS ORDERED BY GORDON JAMES. THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION AS SHOWN AND NOTED HEREON. THE BASIS OF BEARING IS THE NORTH LINE OF SECTION 22, TOWNSHIP 6 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS NORTH 89°13'36" WEST WEBER COUNTY GRID BEARING. CURRENT VESTING DEEDS (E# 845917, 1338915, 827407, 2259591) WERE USED ALONG WITH THE BALLIF ESTATES SUBDIVISION PLAT TO ESTABLISH THE BOUNDARY. THE BOUNDARY OF 2700 WEST WAS DETERMINED BY DEED. THE BOUNDARY OF 1200 SOUTH WAS DETERMINED BY HONORING THE BALLIF ESTATES SUBDIVISION PLAT.

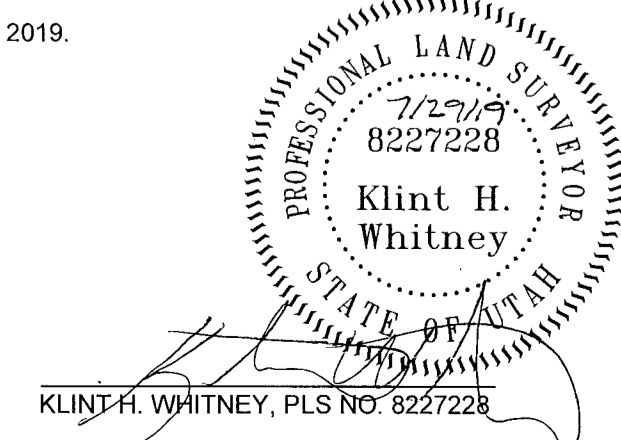
