NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ADJUST AND SET THE PROPERTY CORNERS OF THE PARCELS AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY ROGER ARAVE. THE BASIS OF BEARING IS THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SECTION 3, TOWNSHIP 6 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 89°38'41" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BUY WARRANTY DEED RECORDED AS ENTRY NUMBER 2652799, QUIT CLAIM DEED RECORDED AS ENTRY NUMBER 2521476 AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBERS 946, AND U.D.O.T. RIGHT OF WAY DRAWINGS WERE ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON. DEEDS OF THE SUBJECT PROPERTIES CONTAIN AMBIGUITIES AND MISCLOSURES. DURING THE FIELDWORK OF THIS SURVEY ROGER ARAVE AND ADJOINING PROPERTY OWNER JANET SOUTHWICK TESTIFIED THAT TO THE BEST OF THEIR KNOWLEDGE THE COMMON PROPERTY LINE AS SHOWN HEREON IS THE BOUNDARY BETWEEN THEIR ADJOINING PROPERTIES. IT IS MY RECOMMENDATION THAT A BOUNDARY LINE AGREEMENT ALONG SAID COMMON BOUNDARY SHOULD BE RECORDED.


