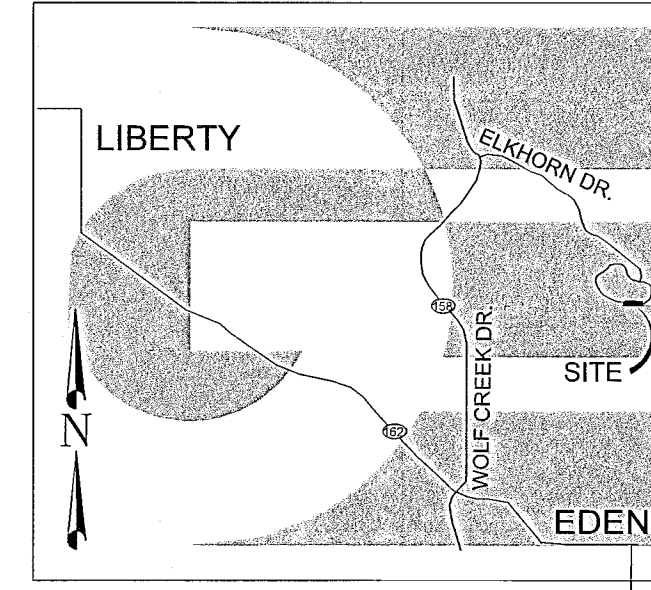


TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 7A

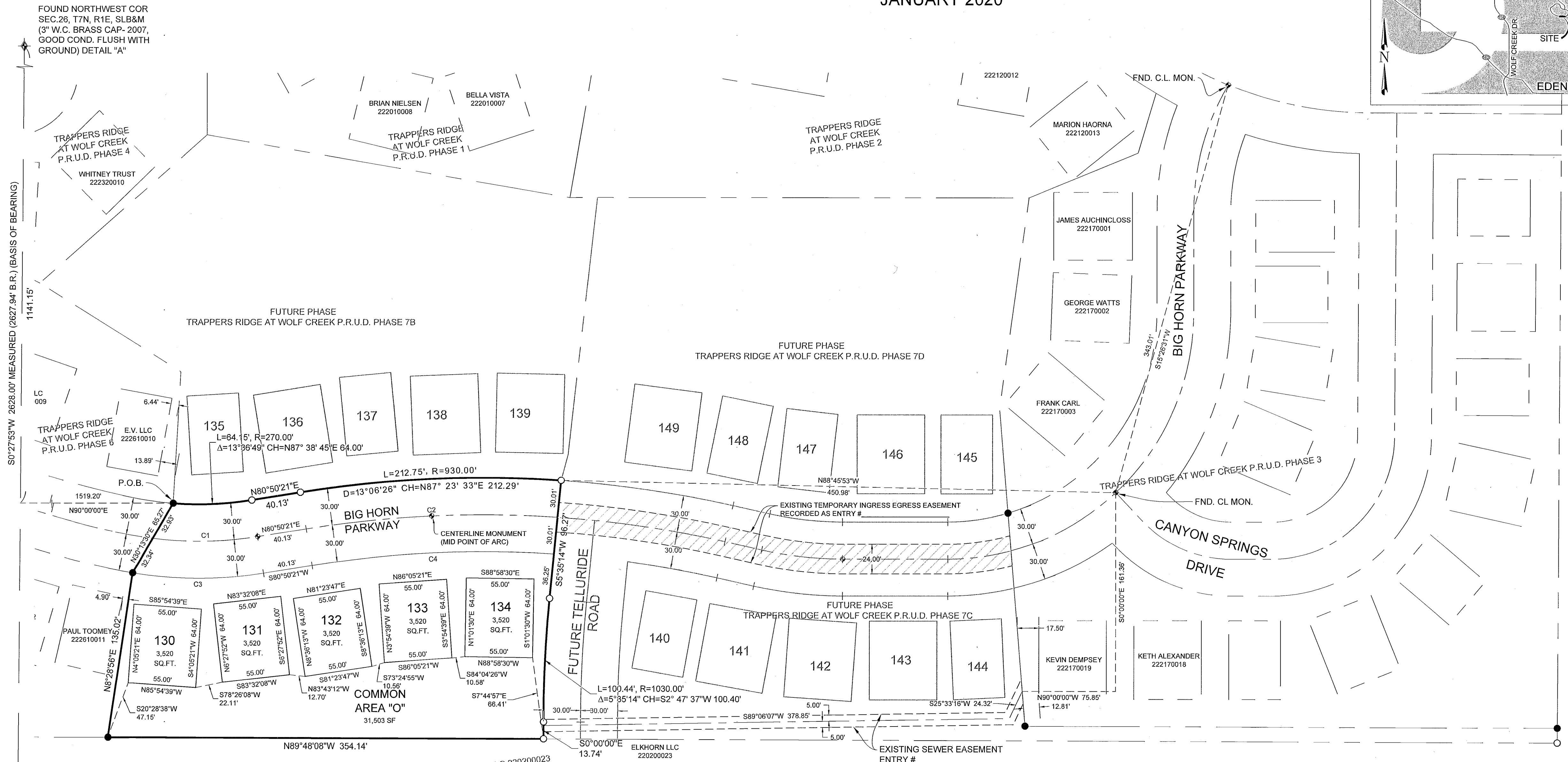
LOCATED IN THE NORTHWEST QUARTER OF SECTION 26,

BOUNDARY DESCRIPTION

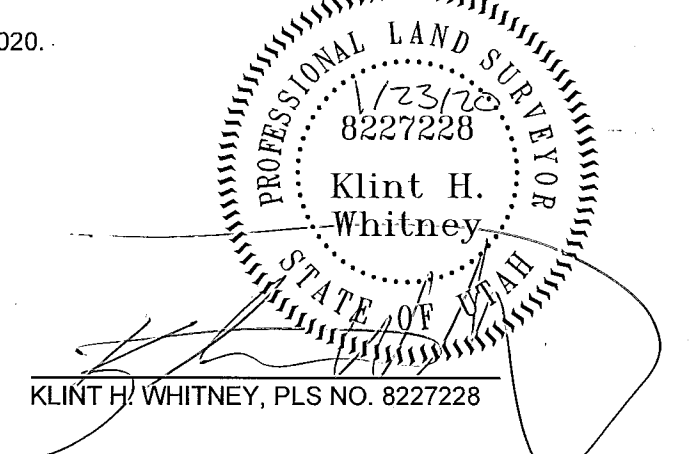
A PART OF THE NORTHWEST QUARTER OF SECTION 26, TOWNSHIP 7 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE NORTHERLY RIGHT-OF-WAY LINE OF BIGHORN PARKWAY, SAID POINT ALSO BEING ON THE EASTERLY LINE OF TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 6, BEING LOCATED SOUTH 0°27'53" WEST 1141.15 FEET AND NORTH 90°00'00" EAST 1519.20 FEET FROM THE NORTHWEST CORNER OF SAID SECTION, RUNNING THENCE ALONG THE ARC OF A CURVE TO THE LEFT 64.15 FEET, HAVING A RADIUS OF 270.00 FEET, A CENTRAL ANGLE OF 13°36'49", AND WHICH CHORD BEARS NORTH 87°38'45" EAST 64.00 FEET; THENCE NORTH 80°50'21" EAST 40.13 FEET; THENCE ALONG THE ARC OF A CURVE TO THE RIGHT 212.75 FEET, HAVING A RADIUS OF 930.00 FEET, A CENTRAL ANGLE OF 13°06'26", AND WHICH CHORD BEARS NORTH 87°23'33" EAST 212.29 FEET; THENCE SOUTH 05°35'14" WEST 96.27 FEET; THENCE ALONG THE ARC OF A 1000.00 FOOT RADIUS CURVE TO THE LEFT 100.44 FEET, HAVING A CENTRAL ANGLE OF 05°35'14", CHORD BEARS SOUTH 02°47'37" WEST 100.40 FEET; THENCE SOUTH 00°00'00" EAST 13.74 FEET; THENCE NORTH 89°48'08" WEST 354.14 FEET TO THE BOUNDARY OF TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 6; THENCE ALONG SAID BOUNDARY NORTH 8°28'56" EAST 135.02 FEET; THENCE CONTINUING ALONG SAID BOUNDARY NORTH 30°13'30" EAST 65.27 FEET TO THE POINT OF BEGINNING. CONTAINING 68.947 SQ.FT. OR 1.583 ACRES, MORE OR LESS.

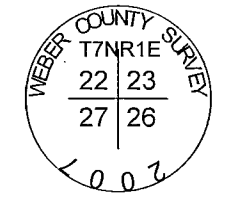

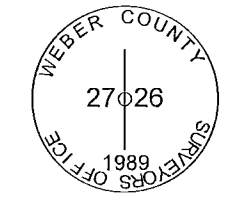
