



LEGAL DESCRIPTION:

WEBER COUNTY ASSESSOR PARCEL NO. 190150032 LOCATED IN THE NORTHWEST QUARTER OF SECTION 24, TOWNSHIP 7 NORTH, RANGE 2 WEST OF THE SALT LAKE MERIDIAN, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT THE CENTER QUARTER CORNER OF SAID SECTION 24, WHENCE THE NORTH QUARTER CORNER OF SAID SECTION 24 BEARS NORTH 00°24'24" WEST A DISTANCE OF 2630.60 FEET, SAID LIINE FORMING THE BASIS OF BEARINGS FOR THIS DESCRIPTION;

THENCE NORTH 00°24'24" WEST ALONG THE EASTERLY LINE OF SAID NORTHWEST QUARTER A DISTANCE OF 332.82 FEET;

THENCE SOUTH 89'35'36" WEST ALONG A LINE PERPENDICULAR TO THE PREVIOUS COURSE A DISTANCE OF 1113.71 FEET TO THE NORTHERLY LINE OF PLEASANT VIEW DRIVE, MARKED BY A PK NAIL IN THE ASPHALT DRIVEWAY AND BEING THE POINT OF BEGINNING:

THENCE NORTH 44"11".15" WEST ALONG SAID NORTHERLY LINE OF PLEASANT VIEW DRIVE A DISTANCE OF 100.56 FEET TO A POINT MARKED BY A NO. 5 REBAR WITH PLASTIC CAP STAMPED "VARA3D";

WE LOCATED AN EXISTING REBAR WITH CAP STAMPED "VARA3D" AT THE WESTMOST, NORTHMOST AND EASTMOST PROPERTY CORNERS OF 1690 W PLEASANT VIEW DRIVE, ASSESSOR PARCEL NO. 190150032. WE HELD THE POSITION OF THESE THREE (3) CORNERS AND SET THE REMAINING CORNERS OF PARCEL NUMBER 190150032 BASED ON THE LEGAL DESCRIPTION OF PARCEL NO. 190150032.




