

## NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JOHN WUMANER. THE CONTROL USED TO ESTABLISH THE PROPERTY CORNERS WAS THE EXISTING OGDEN CITY SURVEY MONUMENTATION SURROUNDING BLOCK 11, PLAT B WHICH FELL IN HARMONY WITH EXISTING FENCE LINES

THE BASIS OF BEARING IS THE CENTERLINE OF MONROE BOULEVARD WHICH BEARS NORTH 1°18'03" EAST, UTAH NORTH, STATE PLANE, CALCULATED N.A.D.83 BEARING.

## AS SURVEYED BOUNDARY DESCRIPTION

A PART OF LOT 10, BLOCK 11, PLAT B, OGDEN CITY, WEBER COUNTY, UTAH SURVEY. MORE PARTICULARLY DESCRIBED AS

BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 10, ALSO BEING A POINT ON THE WEST RIGHT-OF-WAY LINE OF MONROE BOULEVARD LOCATED 314.48 FEET NORTH 01°18'03" EAST ALONG THE CENTERLINE OF MONROE BOULEVARD AND 49.50 FEET NORTH 88°41'34" WEST FROM THE OGDEN CITY SURVEY MONUMENT AT THE INTERSECTION OF MONROE BOULEVARD AND 23RD STREET;

RUNNING THENCE SOUTH 01°18'03" WEST 70.26 FEET (SOUTH 70 FEET BY RECORD) ALONG SAID WEST RIGHT-OF-WAY LINE; THENCE NORTH 88°41'34" WEST (WEST BY RECORD) 165.00 FEET TO AN EXISTING FENCE CORNER; THENCE NORTH 01°18'03" EAST 70.26 FEET (NORTH 70 FEET BY RECORD) TO THE NORTH LINE OF SAID LOT 10; THENCE SOUTH 88°41'34" EAST (EAST BY RECORD) 165.00 FEET TO THE POINT OF BEGINNING. CONTAINING 0.266 ACRES.

SUBJECT TO A 10.00 FOOT WIDE RIGHT-OF-WAY ALONG THE NORTH 10.00 FEET OF THE ABOVE DESCRIBED PROPERTY.




