


#### **NARRATIVE**


THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE PROPERTY BOUNDARY ON THE GROUND AND TO CREATE A LEGAL DESCRIPTION FOR PARCEL B AS SHOWN HEREON. THE BOUNDARIES ON THE EAST AND SOUTH LINES WERE PLACED BY DEED, THE WEST LINE WAS PLACED ALONG SUBDIVISION LINES AS SURVEYED AND SHOWN HEREON. THE NORTH LINE WAS PLACED ALONG THE 1 SECTION LINE.
