
RECORD OF SURVEY **BLAINE HADLEY FARMS SUBDIVISION**

PART OF THE SW QUARTER OF SECTION 33, TOWNSHIP 6 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN



NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO CORRECT THE BOUNDARY BETWEEN THE STRATFORD PROPERTY AND THE HADLEY PROPERTY TO REFLECT THE ACTUAL OCCUPATION AND USE. LINES WERE ESTABLISHED BY EXISTING FENCES, ADJACENT SURVEYS: ON THE EAST #5237 ON THE SOUTH #6137 AND 1841, AND ON THE NORTH BY A BOUNDARY LINE AGREEMENT BETWEEN HADLEY AND STRATFORD. THE WEST LINE BY DEED IS THE SECTION LINE. CORNERS WERE SET WITH A %" REBAR AND PLASTIC CAP STAMPED "KUNZ ENGINEERING". ALL FRONT LOT CORNERS WERE SET AT THE FUTURE RIGHT OF WAY LINE 33' FROM THE
