NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO RE-ESTABLISH AND SET THE PROPERTY CORNERS AND TO WRITE A DESCRIPTION OF THE EXISTING 33' WIDE INGRESS, EGRESS & DRAINAGE EASEMENT AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY MIKE CALLAHAN. THE CONTROL USED TO ESTABLISH THE PROPERTY CORNERS WAS THE OFFICIAL PLAT OF MIDDLE FORK MEADOWS SUBDIVISION PHASE 2, ENTRY NO. 2068110 ALONG WITH THE EXISTING WEBER COUNTY SURVEY MONUMENTATION SURROUNDING SECTIONS 7 & 8, TOWNSHIP 6 NORTH, RANGE 2 EAST, SALT LAKE BASE & MERIDIAN.

THE BASIS OF BEARING IS THE EAST LINE OF SAID SECTION 7 WHICH BEARS SOUTH 0°27'07" WEST, AS SHOWN ON THE OFFICIAL PLAT OF SAID MIDDLE FORK MEADOWS SUBDIVISION PHASE 2.

A 33.00 FOOT WIDE INGRESS, EGRESS & DRAINAGE EASEMENT ACROSS THE SOUTH 33.00 FEET OF LOT 1,

MIDDLE FORK MEADOWS SUBDIVISION PHASE 2, RECORDED AS ENTRY NO. 2068110 SITUATED IN THE

NORTHEAST QUARTER OF SECTION 7 AND THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 6 NORTH,

RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN. BEING 33.00 FEET RIGHT OF THE FOLLOWING DESCRIBED
