


## **BOUNDARY DESCRIPTION**

A PART OF THE NORTHEAST QUARTER OF SECTION 26, TOWNSHIP 6 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN. BEGINNING AT A POINT ON THE WEST RIGHT-OF-WAY LINE OF 1900 WEST STREET BEING LOCATED NORTH 00°50'13" EAST 674.59 FEET ALONG THE EAST LINE OF SAID NORTHEAST QUARTER; RUNNING THENCE ALONG SAID RIGHT-OF-WAY LINE OF 1900 WEST AND THE NORTH RIGHT-OF-WAY LINE OF 2100 SOUTH STREET THE FOLLOWING SEVEN (7) COURSES: (1) NORTH 31°22'47" WEST 37.48 FEET; (2) SOUTH 00°50'38" WEST 21.50 FEET; (3) NORTH 89°29'29" WEST 200.31 FEET; (4) SOUTH 83°12'38" WEST 102.34 FEET; (5) SOUTH 87°51'42" WEST 40.83 FEET; (6) SOUTH 85°12'52" WEST 203.94 FEET; (7) SOUTH 88°00'38" WEST 35.04 FEET TO THE EAST BOUNDARY LINE OF THE NAMPIL SUBDIVISION; THENCE ALONG SAID EAST LINE THE FOLLOWING TWO (2) COURSES: (1) NORTH 00°50'13" EAST 552.34 FEET; (2) NORTH 74°48'18" WEST 39.49 FEET; THENCE NORTH 00°50'13" EAST 32.30 FEET TO THE SOUTHERLY LINE OF A RAIL SPUR; THENCE ALONG THE SOUTHERLY LINE OF SAID RAIL SPUR THE FOLLOWING FIVE (5) COURSES: (1) ALONG THE ARC OF A 434.56 FOOT RADIUS CURVE TO THE RIGHT 156.69 FEET, HAVING A CENTRAL ANGLE OF 20°39'33", CHORD BEARS SOUTH 63°04'21" EAST 155.84 FEET; (2) SOUTH 53°19'46" EAST 383.89 FEET; (3) ALONG THE ARC OF A 439.36 FOOT RADIUS CURVE TO THE RIGHT 219.45 FEET, HAVING A CENTRAL ANGLE OF 28°37'05", CHORD BEARS SOUTH 39°01'13" EAST 217.18 FEET; (4) SOUTH 23°46'59" EAST 93.00 FEET; (5) ALONG THE ARC OF A 570.67 FOOT

## NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY BRENT BAILEY. PARCEL "A" IS NOT APPROVED FOR DEVELOPMENT AT THIS TIME AND WILL NEED TO GO THROUGH THE WEST HAVEN CITY SUBDIVISION PROCESS TO RECEIVE BUILDING ENTITLEMENTS. THE BASIS OF BEARING IS THE EAST LINE OF THE NORTHEAST QUARTER OF SECTION 26, TOWNSHIP 6 NORTH, RANGE 2 WEST, WHICH BEARS NORTH 00°50'13" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BUY WARRANTY DEEDS RECORDED AS ENTRY NUMBERS 2791981, 1750506, AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBERS 6566, 4000, 6376, AND THE DEDICATED PLATS OF NAMPIL SUBDIVISION WERE ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON.
