


BOUNDARY DESCRIPTION

THE WEST 12.5 FEET OF THE SOUTH 101.10 FEET OF LOT 5 AND THE SOUTH 101.1 FEET OF LOT 6, BLOCK 9, TERRACE SUBDIVISION IN OGDEN CITY WEBER COUNTY MORE PARTICULARLY DESCRIBED

BEGINNING THE A POINT ON THE NORTH RIGHT-0F-WAY LINE OF CROSS STREET BEING LOCATED SOUTH 88°55'39" EAST 204.50 FEET ALONG THE MONUMENTED CENTERLINE OF CROSS STREET AND NORTH 01°10'02" EAST 25.00 FEET FROM THE CENTERLINE INTERSECTION MONUMENT AT GRANT AVENUE AND CROSS STREET; RUNNING THENCE NORTH 01°10'02" EAST 101.55 FEET; THENCE SOUTH 88°52'36" EAST 37.50 FEET; THENCE SOUTH 01°10'02" WEST 100.52 FEET; TO SAID NORTH RIGHT-OF-WAY LINE; THENCE ALONG SAID NORTH RIGHT-OF-WAY LINE NORTH 88°55'39" WEST 37.50 FEET TO THE POINT OF BEGINNING. CONTAINING 3791 SQUARE FEET.

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH THE BOUNDARIES OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY KEVIN PEREZ. FINAL ORDER AND JUDGMENT CASE NO. 180900689 RECORDED AS ENTRY NUMBER 2923179, HISTORICAL DEED RECORDED AS ENTRY NUMBER 942201, THE DEDICATED PLAT OF THE TERRACE SUBDIVISION TO OGDEN CITY UTAH, FOUND OGDEN CITY CENTERLINE MONUMENTS AND FOUND PROPERTY CORNERS FROM RECORDED SURVEYS OF ADJOINING PROPERTIES WERE USED TO DETERMINE THE BOUNDARY. THE BASIS OF BEARING IS THE CENTERLINE OF 9TH STREET BETWEEN THE OGDEN CITY MONUMENTS AT THE INTERSECTION OF GRANT AVENUE AND WASHINGTON BOULEVARD WHICH BEAR SOUTH 88°49'33" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID
