SURVEYOR'S NARRATIVE

THIS SURVEY WAS REQUESTED BY DEBRA WICKIZER FOR THE PURPOSE OF RE-ESTABLISHING THE BOUNDARIES OF THE HEREON DESCRIBED PARCELS OF LAND. BRASS CAP MONUMENTS WERE FOUND AT THE EAST QUARTER CORNER AND NORTHEAST CORNER OF SECTION 27, TOWNSHIP 5

A LINE BEARING NORTH 0°18'36" EAST BETWEEN SAID BRASS CAP MONUMENTS AT THE EAST QUARTER CORNER AND NORTHEAST CORNER OF SAID SECTION 27, WAS USED AS THE

BASIS OF BEARINGS FOR THIS SURVEY. MOUNTAIN VALLEY RANCHETTES PREPARED BY JESSE ALLEN, DATED APRIL 25, 1975, AND FILED DECEMBER 15, 1975; AND MOUNTAIN VALLEY RANCHETTES PHASE 2 PREPARED BY KENT ARAVE, DATED APRIL 3. 1979, AND FILED APRIL 26, 1979; WERE USED AS REFERENCE FOR THIS SURVEY.

BOUNDARIES OF THE PARCELS WERE ESTABLISHED BY INFORMATION OF RECORD AND FOUND EVIDENCE OF OCCUPATION ON THE GROUND. BASED ON EVIDENCE OF OCCUPATION AROUND THE SUBDIVISION WHERE THE SUBJECT PROPERTY RESIDES, IT APPEARS THE EAST LINE OF MOUNTAIN VALLEY RANCHETTES DOES NOT FOLLOW THE EAST LINE OF THE NORTHEAST QUARTER OF SECTION 27 AS THE PLAT OF RECORD SEEMS TO INDICATE. SAID EAST LINE HAS A ROTATION OF 0°14'00" OFF THE SECTION LINE PER MEASUREMENTS TAKEN IN THE FIELD.
