

NARRATIVE


THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET AND ADJUST THE PROPERTY CORNERS OF THE PARCELS AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY DAVID GILL. THE BASIS OF BEARING IS THE MONUMENTED STREET CENTER LINE OF 28TH STREET BETWEEN MADISON AVENUE AND ADAMS AVENUE WHICH BEARS NORTH 88°42'08" WEST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BUY WARRANTY DEED RECORDED AS ENTRY NUMBER 2860172 AND 3019887, AND DEEDS OF ADJOINING PROPERTY OWNERS. RECORD OF SURVEY NUMBERS 5673 WAS ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND DESCRIBED HEREON.
