

PARCEL NO. 1 AS-SURVEYED BOUNDARY DESCRIPTION

A PART OF THE NORTHWEST QUARTER OF SECTION 30, TOWNSHIP 6 NORTH, RANGE 1 WEST OF THE

BEGINNING AT A POINT ON THE EAST RIGHT-OF-WAY LINE OF 1100 WEST STREET LOCATED 1127.85 FEET NORTH 00°34'56" EAST (68 RODS 5.5 FEET NORTH BY RECORD) ALONG THE WEST LINE OF SAID NORTHWEST QUARTER AND 37.31 FEET SOUTH 89°01'33" EAST (2 RODS EAST BY RECORD) FROM THE WEST QUARTER CORNER OF SAID SECTION 30;

RUNNING THENCE NORTH 00°58'27" EAST (NORTH BY RECORD) 445.50 FEET ALONG SAID EAST RIGHT-OF-WAY LINE; THENCE NORTH 89.51'09" EAST 171.48 FEET (EAST 181.5 FEET BY RECORD); THENCE SOUTH 00°00'49" WEST 448.92 FEET (SOUTH 27 RODS BY RECORD); THENCE NORTH 89°01'33" WEST 178.97 FEET (WEST 181.5 FEET BY RECORD) TO THE POINT OF BEGINNING.

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCELS AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY RYAN STEARNS. THE CONTROL USED TO ESTABLISH THE PROPERTY CORNERS WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION SURROUNDING SECTION 30, T6N, R1W, SLB&M.

THE BOUNDARY OF THE SUBJECT PROPERTIES IS CONTROLLED BY THE FOLLOWING: THE NORTH BOUNDARY WAS DETERMINED BY VESTING DEEDS, WHICH FALLS IN HARMONY WITH AN EXISTING FENCE LINE AND FOUND REBAR. THE EAST BOUNDARY WAS DETERMINED FROM ROS# 3424, WHICH FALLS IN HARMONY WITH EXISTING OCCUPATION. THE SOUTH BOUNDARY WAS DETERMINED BY VESTING DEEDS. THE WEST BOUNDARY IS THE EAST RIGHT-OF-WAY LINE OF 1100 WEST AND WAS ESTABLISHED FROM DEEDS AND ROS'S IN THE AREA, WHICH FALLS IN HARMONY WITH EXISTING FENCE ALONG SAID

RIGHT-OF-WAY PLANS WERE OBTAINED FROM UDOT FOR 21ST STREET, BUT LIMITED INFORMATION WAS SHOWN ON THE WEST SIDE OF THE RANGE LINE. THEREFORE THE VESTING DEEDS WERE HELD TO

THE BASIS OF BEARING IS THE WEST LINE OF THE NORTHWEST QUARTER OF SAID SECTION WHICH BEARS NORTH 0°34'56" EAST, UTAH NORTH, STATE PLANE, CALCULATED N.A.D.83 BEARING.
