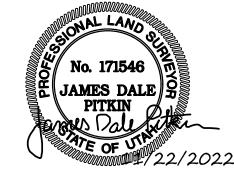

<u>NARRATIVE</u>

A survey of the subject property was completed as part of an ALTA/NSPS Land Title Survey requested by Russel King. A Commitment for Title Insurance Commitment No. NCS—1137649—SLC1, dated July 18, 2022, prepared by First American Title Insurance Company was provided and relied upon for the preparation of this survey.

The basis of bearings for this survey is North 00°44'28" East between the 1980 Bureau of Land Management monuments marking the Southeast and East Quarter Corners of Section 22, Township 6 North, Range 1 West, Salt Lake Base & Meridian.

Numerous discrepancies and inconsistencies exist between the Weber County GIS Map (Geo-Gizmo), the published Weber County Ownership Plat maps, and the record property descriptions. The ownership information and Tax Parcel configurations on the Weber County Ownership Plat maps more accurately reflect the actual locations of property parcels in the area, however, a number of inaccuracies are still depicted.

The Title Commitment includes Tax Parcel No. 13—074—0002 in its entirety, however, the subject property specified for this survey includes only that portion of said Tax Parcel south of Highway 39 and west of the United States of America parcel identified as Tax Parcel No. 13—074—0006.

Discrepancies in location between the 1980 Bureau of Land Management (BLM) Section corner monuments found and the locations depicted on the Ogden City "Bible" sheet corner locations are apparent and documented in several surveys of record (Ref. 6). Many of the record property descriptions appear to have been written utilizing the Ogden City "Bible" sheet locations and match existing improvements, but no actual monuments were found or have been documented in those locations. The Ogden City Monuments found in Valley Drive were used as a basis for orienting the "Bible" sheet section corner locations. The calculated corner locations shown were utilized as the basis for the record property descriptions. The relationship between the calculated corner locations and the BLM monuments found are shown. A control/section breakdown detail is provided on Sheet 3.

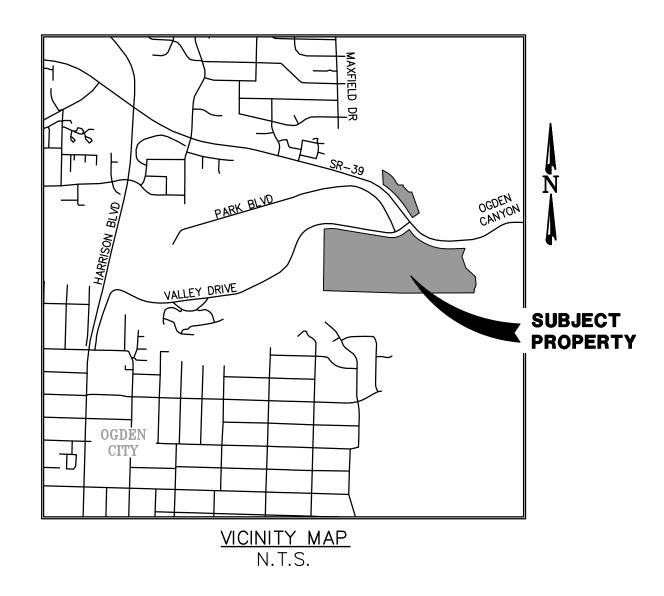
The BLM monuments were used to control the southerly line of the subject property. The north line of the northerly parcels of the subject property, being the north line of the South 2/3 of the East 1/2 of the Southeast Quarter of Section 22, was determined from the Ogden City "Bible" Sheets and agrees well with the record deed lines of the properties in this area.

The location of SR-39 right of way was based upon the calculated "Bible" sheet corner locations and the associated right of way drawings for UDOT Project No.'s SU-0568(6) & RS-0568(16). No right of way monuments were found during the course of fieldwork to further delineate the right of way. The basis of location for the right of way plans is the monument at the intersection of Valley Drive and Park Boulevard along with ties to the Ogden City "Bible" sheets.

The record location of the right of ways of Valley Drive and Park Boulevard, as shown on the Ogden City "Bible" sheets, adjacent deed calls and Ogden City monuments found in Valley Drive, do not agree entirely with the existing improvements of both roads. The Ogden City Monuments found in Valley Drive were used for the initial road right of way, but the alignment of the existing road improvements diverge significantly from the "Bible" sheet location continuing westerly. The alignment of Valley Drive as shown is based upon a best fit alignment following the existing improvements. Ogden City was not able to provide any documentation that matches the alignment of Valley Drive as constructed.
