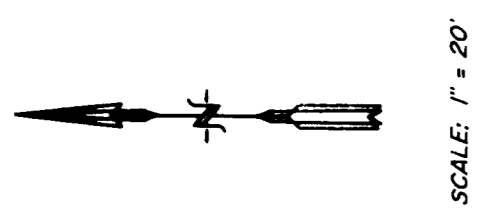
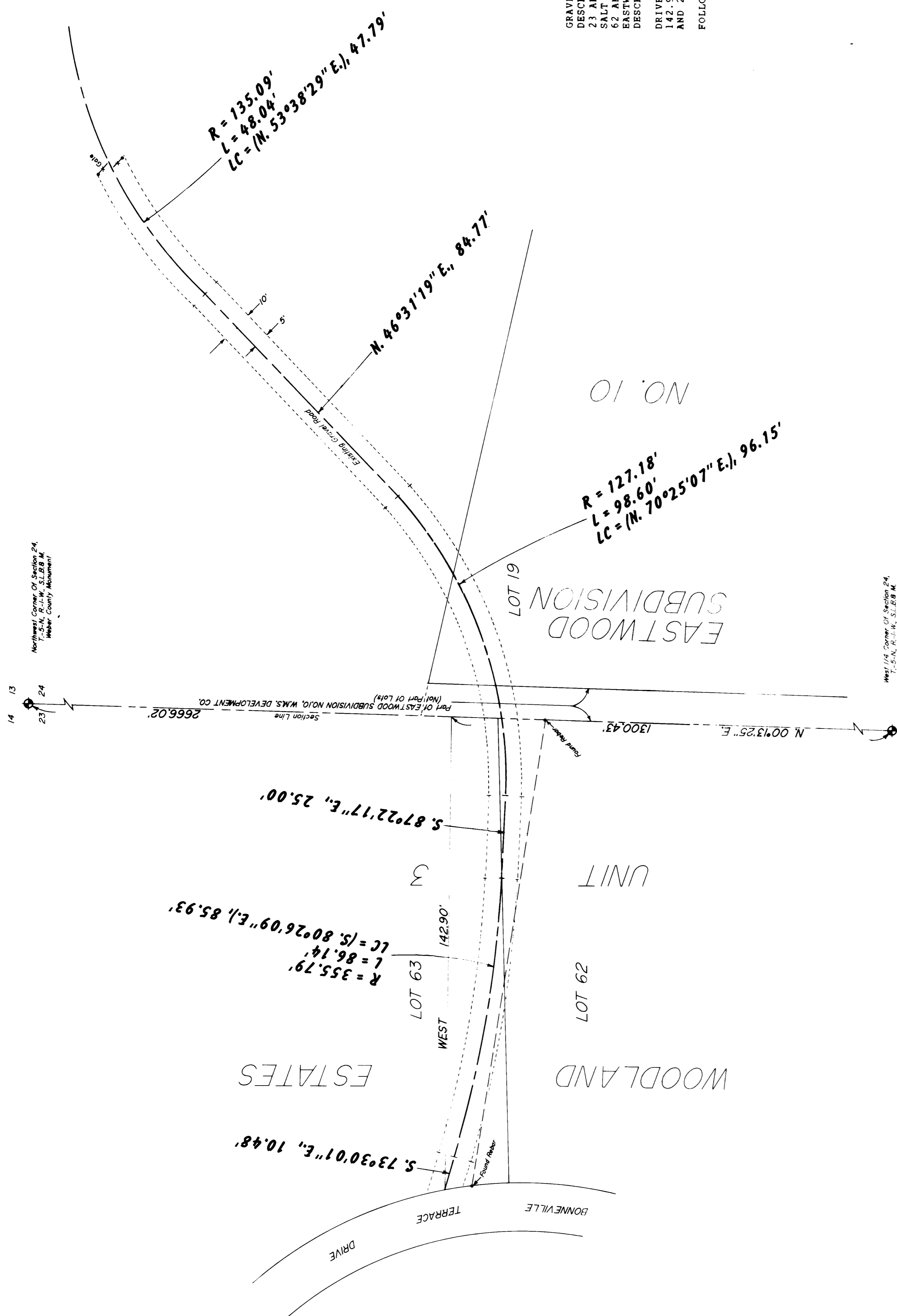


# ACCESS EASEMENT SURVEY



ACCESS ROAD DESCRIPTION  
BEING A 10 FOOT WIDE ACCESS ROAD EASEMENT ALONG AN EXISTING GRAVEL CENTERLINE, BEING SITUATED IN THE EAST HALF OF SECTION 23 AND THE WEST HALF OF SECTION 24, TOWNSHIP 5 NORTH RANGE 1 WEST SALT LAKE BASE AND MERIDIAN AND FURTHER BEING LOCATED ACROSS LOTS EASTWOOD 10 SUBDIVISION, AND LOT 19 OF EASTWOOD 10 SUBDIVISION DESCRIBED AS FOLLOWS:

DRIVE BEGINNING AT A POINT ON THE EAST LINE OF BONNEVILLE TERRACE 142.90 FEET FROM THE QUARTER CORNER COMMON TO SAID SECTIONS 23 AND 24, AND RUNNING:

FOLLOWING 6 CALLS:

1. S. 73°30'01" E. 10.48 FEET;
2. ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS BEARS S. 80°26'09" E. 85.93 FEET;
3. S. 87°22'17" E., 25.00 FEET;
4. ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS BEARS N. 70°25'07" E. 96.15 FEET;
5. N. 46°31'19" E., 84.77 FEET;
6. ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS BEARS N. 53°38'29" E., 47.79 FEET TO AN EXISTING GATE.
