

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCEL AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY TYSON JACKSON FOR PLEASANT VIEW CITY. THE CONTROL USED TO ESTABLISH THE PROPERTY CORNERS WAS MOUNTAIN ESTATES SUBDIVISION, ENTRY NO. 668920, PLEASANT VIEW HEIGHTS NO. 5, ENTRY NO. 1346254, OGDEN-BRIGHAM CANAL MAPS, EXISTING FENCE LINES AND FOUND SURVEY MARKERS ALONG WITH THE EXISTING WEBER COUNTY SURVEY MONUMENTATION SURROUNDING SECTION 19, T7N, R1W, SLB&M.

THE BASIS OF BEARING IS THE EAST LINE OF THE SOUTHEAST QUARTER OF SAID SECTION WHICH BEARS NORTH 0°50'51" EAST, UTAH NORTH, STATE PLANE, CALCULATED N.A.D.83 BEARING.

AS SURVEYED BOUNDARY DESCRIPTION

A PART OF THE SOUTHEAST QUARTER OF SECTION 19, TOWNSHIP 7 NORTH, RANGE 1 WEST OF THE

BEGINNING AT THE INTERSECTION OF THE WEST RIGHT-OF-WAY LINE OF 500 WEST STREET AND THE NORTHERLY RIGHT-OF-WAY LINE OF THE OGDEN-BRIGHAM CANAL LOCATED 2326.33 FEET NORTH 00°50'51" EAST ALONG THE EAST LINE OF SAID SOUTHEAST QUARTER AND 526.65 FEET NORTH 89°09'09" WEST FROM THE SOUTHEAST CORNER OF SAID SECTION 19;

RUNNING THENCE ALONG SAID NORTHERLY RIGHT-OF-WAY LINE THE FOLLOWING FOUR (4) COURSES: (1) NORTH 66°09'46" WEST (NORTH 66°30'30" WEST BY RECORD) 15.35 FEET; (2) SOUTH 23°50'14" WEST (SOUTH 23°26'30" WEST BY RECORD) 5.00 FEET; (3) NORTH 66°09'46" WEST 168.77 FEET (NORTH 66°30'30" WEST 168.8 FEET BY RECORD); AND (4) NORTHWESTERLY TO THE RIGHT ALONG THE ARC OF A 185.00 FOOT RADIUS CURVE, A DISTANCE OF 14.88 FEET, CHORD BEARS NORTH 63*51'32" WEST 14.87 FEET, HAVING A CENTRAL ANGLE OF 04°36'29" TO AN ANGLE POINT IN THE BOUNDARY OF LOT 2, MOUNTAIN ESTATES SUBDIVISION, RECORDED AS ENTRY NO. 668920 IN THE WEBER COUNTY RECORDER'S OFFICE; THENCE ALONG THE BOUNDARY OF SAID LOT 2 THE FOLLOWING TWO (2) COURSES: (1) NORTH 00°55'44" EAST 110.20 FEET (NORTH 0°32' EAST 109.74 FEET BY RECORD); AND (2) SOUTH 89°04'16" EAST 185.00 FEET TO THE SOUTHEAST CORNER OF LOT 1 OF SAID MOUNTAIN ESTATES SUBDIVISION BEING A POINT ON SAID WEST RIGHT-OF-WAY LINE; THENCE SOUTH 00°55'44" WEST 183.60 FEET ALONG SAID WEST RIGHT-OF-WAY LINE TO THE POINT OF BEGINNING.






