

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS AND ADJUST THE PARCELS AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JANE WILSON FONG. THE BASIS OF BEARING IS THE STREET CENTERLINE OF WASHINGTON BOULEVARD BETWEEN 37TH STREET AND 38TH STREET, WHICH BEARS SOUTH 1°17'43" EAST, WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE BOUNDARY WAS DETERMINED BY WARRANTY DEED RECORDED AS ENTRY NUMBER 3035056, AND DEEDS OF ADJOINING PROPERTY OWNERS. THE DEDICATED PLATS OF BLOCKS 29 & 30 LAKE VIEW ADDITION WERE ALSO USED TO DETERMINE BOUNDARY LOCATION ALONG WITH THE FOUND MONUMENTS AS SHOWN AND
